FEDERAL REGIONAL COUNCIL REGION IX

The Federal Regional Council (FRC) grew out of the Region IX Federal Interagency Welfare Reform Task Force established by HHS in 1996 to meet the challenges of welfare reform. This Task Force experience demonstrated that federal regional staffs working together can achieve better outcomes for the public we serve. In 1998, Task Force members proposed expanding its work to a broader mission promoting a range of issues in support of children, families, and communities in Region IX. In this way, welfare reform, welfare-to-work, transportation, the environment, immigration, nutrition, economic development and other issues can be coordinated by an expanded federal body.

The new FRC was established in November 1998 and the HHS Regional Director was elected by the Council as its permanent Chair. With an expanded mission, the consortium provides a framework for participating federal agencies to work together in a coordinated fashion to define and solve larger problems. The consortium is now comprised of seventeen separate federal Departments and Agencies representing nearly thirty different federal program offices. Specifically, the membership includes regional representatives from the following federal Departments: Agriculture, Commerce, Education, Energy, Health and Human Services, Homeland Security, Housing and Urban Development, Justice, Labor, Interior, Transportation, and Veterans Affairs; and the following federal Agencies: Environmental Protection Agency, Small Business Administration, General Services Administration, Social Security Administration, Internal Revenue Service, Minority Business Development Agency and the Federal Deposit Insurance Corporation.

The FRC meets monthly and, as reflected in the organization chart, has six committees focused upon broad geographic areas and/or special populations in the vast expanse of Region IX. The six entities are the **Border Committee**, the **Faith-Based and Community Initiatives Committee**, the **Homelessness Committee (Interagency Council on Homelessness)**, the **Outer Pacific Committee**, the **San Joaquin Valley Committee/Task Force**, and the **Tribal Affairs Committee**. Executive Orders or Administration initiatives serve as the underlying authority to guide each committee's work in fulfilling Administration priorities.

Overview Continued

Among its many accomplishments in the past year of 2007 are the following:

- Completed the Federal Regional Council Report to the White House for 2005-2006 on the San Joaquin Valley in January 2007 in fulfillment of EO 13173 and submitted to the HUD Secretary in Washington, DC. The report was then approved and distributed in May 2007.
- Entered in a partnership with the City & County of San Francisco on the "Communities of Opportunity" Initiative. The FRC attended a site visit of target Bayview-Hunters Point neighborhood held in April 2007 and completed an FRC Resources inventory in December 2007, an effort led by HUD.
- Held the Grand Opening of the new San Francisco Federal Building conducted by GSA, climaxing the monumental move of four key FRC members into the building. The members in the new building are DOL, HHS, SSA, and USDA/FNS.
- Engaged in a partnership starting in March 2007 with the Department of Defense's Office of Economic Adjustment regarding the planned military build-up on Guam and the impact on its domestic programs. This effort has led to visits with FRC by Guam Governor Camacho in September and December and the establishment of an "FRC Action Plan for Guam", with designated Points of Contact for each involved FRC member.
- Initiated clothing drives for veterans, including homeless veterans, served by the VA's Downtown Clinic, an effort yielding tremendous contributions made by FRC members. Participation by USDA/FNS, HHS, HUD, SSA, DOL, and FDIC in 2007 will be expanded in 2008 in light of its success to meet the growing population of veterans needing assistance.
- Convened a meeting with Salinas Mayor Dennis Donohue at the request of Rep. Sam Farr on October 10, 2007 regarding domestic program needs to address youth violence in Salinas and Monterey County. In follow-up to the meeting, the FRC Issued in November 2007 a "Resources Inventory for Salinas," which was further expanded and revised in December 2007. The Salinas delegation in its subsequent visit to Washington, DC acknowledged the assistance of the FRC to headquarter offices.

Overview Continued

- Coordinated FRC communications in response to the Southern California Wildfires that heavily impacted Tribes. To improve future FRC preparedness efforts based on lessons learned, the FRC Chair met with FEMA Regional Administrator to propose an FRC Roundtable to clarify FEMA policies and procedures invoked during times of natural disasters. The effectiveness of the federal response by Region IX was acknowledged by California Governor Schwarzenegger in his 2008 State of the State address.

Region IX is proud that we are the only region in the country with an FRC, and whose track record provides ample evidence that federal agencies working together result in improved working relationships, stronger partnerships, and more effective programs. This building of trust by the federal partners has also had a catalytic effect upon state and local governments, non profit organizations and philanthropic institutions who often welcome the opportunity to be partners in a larger collaborative. In particular, the FRC is pleased that its work supports the important principles of the President's Management Initiative in making government citizen-centered, results-oriented, and innovative in practice.
